Description: Foldable with circular carrying bag. Compact for storage Easy to set up — unfolds automatically once unpacked


Dimensions open:

- length: minimum 240cm, maximum 250cm
- width: minimum 240cm, maximum 250cm
- height: minimum 170cm, maximum 180 cm

Fabric Material: 190T POLYESTER, waterproof for wall and floor, mosquito net roof which is removable. Carbon steel frame.

Weight (packed): 7.5kg max

Logo Printing:







Doors have one layer mosquito net with zipper and one layer polyester with zipper

Tents are modular and can be easily connected

Color: Blue PANTONE 286C (with interior silver coating)

lightweight and portable, washable, and quick drying.

Logos: 1 IOM logo on both doors and sides)

Carrying Bag:

Foldable with circular carrying bag with one end opening. Compact for storage.

The tent bag is made of the same POLYESTER material as the one used for the tent.

Marking on the Carrying Bag:

The buyer's markings (clearly readable) must be printed on the outside indelible ink: Marking as per Purchase Order.

Packaging:

The items to be packed in Wooden EURO pallet (EUR 1) and treated as per ISPM 15 standard.

Items must be shrink-wrapped, securely strapped

and sealed. The packaged goods must not exceed the length and width of the pallet and clearly marked with IOM standard markings as per Purchase Order in both front and back.
