## **INVITATION TO SUBMIT EXPRESSION OF INTEREST**

The International Organization for Migration (IOM) is an intergovernmental humanitarian organization established in 1951 and is committed to the principle that humane and orderly migration benefits both migrants and society.

IOM Bids Evaluation and Award Committee (“BEAC”) now invites Expression of Interest from *Companies (Manufacturer or Authorized Distributer for Iraq)* for the *Project of Supplying, Installing, and Commissioning X-Ray Scanning Device for Passenger Vehicles for Trebil Border Control Point*

The Expression of Interest shall contain information on the following:

1. Company profile (national or an international company) showing relevant services offered.
2. For National Company, they have to submit a manufacturer Authorization letter that shows the vendor is the exclusive dealer or authorized to sell this product in Iraq. The Authorization letter should be certified by the Iraqi embassy in country of origin.
3. For International Company (Manufacturer or Authorized distributor for Iraq), they must have an office in Iraq that provides the service and maintenance, or an official national representative company that support their projects in Iraq according to the manufacturer Authorization letter that should be certified by the Iraqi embassy in the country of origin.
4. Company valid official registration documents proving that the company is allowed to provide such services.
5. Track record and experience of the company in similar assignment including a list of major clients served during last three years please provide testimonies (copy of contracts and certificates of completion) for this purpose.
6. Current bank statement or annual turnover for 2021 with a total value not less than USD 1000,000
7. Bank account information (should be in the name of the company).
8. Interested suppliers must submit all the requested documents listed above in this EOI Requirements. In the absence of specific documents as indicated, other documentation providing similar information may be accepted by the evaluation panel at its own discretion. In this regards the evaluation panel reserves the right to request additional information, documents or further clarification from one or multiple bidders.
9. Other relevant information.

Please note that the capacity of the email should not exceed 9MB otherwise will be neglected by our server.

On the basis of the above information, the BEAC shall draw up the shortlist of Service Providers. Only short-listed Service Providers will be invited to submit technical and financial proposals.

The BEAC reserves the right to accept or reject any Expression of Interest, and to annul the selection process and reject all Expression at any time, without thereby incurring any liability to the affected Service Providers.
