The International Organization for Migration (hereinafter called **IOM**) intends to engage qualified non-governmental organizations (NGOs) to submit expression of interest as Implementing Partners for the projects *“Critical winterization and livelihoods support to the most vulnerable communities in Eastern Ukraine”* and *“Provision of Lifesaving Non-Food Items and WASH Support for the Most Vulnerable Households in Luhansk and Donetsk (NGCA)”*.

The project will be implemented given the availability of funding.

IOM now invites NGOs operating on non-government controlled areas of Donetsk Oblast of Ukraine to submit Project and Budget Proposal on project aimed at winterization support to vulnerable IDPs, returnees and other conflict-affected communities in the East of Ukraine ***through monitoring of coal distribution to vulnerable households***.
