In view of the above, IOM now requests *Information* from *Service Providers* for the provision of mobile clinics with driver and nurses under rental to provide COVID-19 vaccines in Beirut and in North areas. At the moment we are still working on the fixed schedule of distribution.

The Information shall contain the following a.) Company profile including the previous experience in provision of mobile clinics with driver and nurse rental services b.) scope of services offered including standard rates per day, per week or per month in USD for different types of mobile clinics with driver and nurse c.) List of locations covered in Lebanon d.) Standard payment terms

On the basis of this RFI, IOM shall draw up Scope of Services from the gathered information which may be issued later as a Request for Quotation (RFQ).

Please also note that IOM does not intend to pay for any information furnished in response to this RFI or will not be responsible for any costs incurred by the vendors related to the response to this RFI or any other activities related to the preparation of information. This call for RFI does not constitute a solicitation.

Please note that this is not an Expression of Interest (EoI), and therefore the outcome of this survey may not necessarily result in an Invitation to Bid or a Request for Proposal.
