| 7 | What is the period of the long term agreement? | One (1) year with the possibility of one (1) year extension. |
| 8 | What is the delivery schedule? | Under the LTA, when IOM issued Purchase Order (PO), the goods shall be delivered to the place according to the delivery schedule outlined in each PO based on the earliest availability of items. Note that IOM will send request to the LTA holder/s to check availability prior issuance of orders. |
| 9 | Is there a possibility to accept medicines, of known brands, directly imported for your needs? | IOM will purchase the pharmaceutical products depending on our requirements as and when needed. Therefore, direct importation of medicines specifically for IOM is not advisable unless suppliers have other clients requiring the same. As indicated on item no. 6, LTA is non exclusive and non binding. A purchase may or may not be made. If there are alternative offer, please indicate in the Technical Specifications Form |
| 14 | Can we quote in CIF -Lebanon Airport instead of Delivery at place? | This will not be applicable since this tender is open to local vendors only or vendors who have the capacity to deliver goods to IOM without involving IOM on customs clearance. |
