## **SECTION 2: INSTRUCTIONS TO PROPOSERS**

GENERAL	
1. Scope	Proposers are invited to submit a proposal for the services/works specified in Section 5: Terms
	of Reference/Scope of Works, in accordance with this Request for Proposal (RFP). A summary of the scope of the proposal is included in Section 3: Data Sheet.
	Proposers shall adhere to all the requirements of this RFP, including any amendment made in writing by IOM. This RFP is conducted in accordance with Policies and Procedures of IOM.
2. Interpretation of the RFP	Any proposal submitted will be regarded as an offer by the proposer and does not constitute or imply the acceptance of the proposal by IOM. IOM is under no obligation to award a contract to any proposer as a result of this RFP.
3. Supplier Code of Conduct	All proposers must read the United Nations Supplier Code of Conduct and acknowledge that it provides the minimum standards expected of suppliers to the IOM. The Code of Conduct, which includes principles on labour, human rights, environment and ethical conduct may be found at: <a href="https://www.ungm.org/Public/CodeOfConduct">https://www.ungm.org/Public/CodeOfConduct</a> .
4. Eligible proposers	Proposers shall have the legal capacity to enter into a binding contract with IOM Germany
	A proposer, and all parties constituting the proposer, may have the nationality of any country with the exception of the nationalities, if any, listed in Section 3: Data Sheet. A proposer shall be deemed to have the nationality of a country if the proposer is a citizen or is constituted, incorporated, or registered and operates in conformity with the provisions of the laws of that country.
	All proposers found to have a conflict of interest shall be disqualified. Proposers may be considered to have a conflict of interest if they are or have been associated in the past, with a firm or any of its affiliates that have been engaged by Click or tap here to enter text. to provide consulting services for the preparation of the design, specifications, Terms of Reference, cost analysis/estimation and other documents to be used for the procurement of the services required in the present procurement process.
	Proposers shall not be eligible to submit a proposal if at the time of proposal submission:

All documents which may form part of the proposal will become the property of IOM, who will not be required to return them to your firm.
6. Publicity	During the RFP process, a proposer is not permitted to create any publicity in connection with the RFP.
SOLICITATION DOCUMENTS	
7. Clarification of solicitation documents	Proposers may request clarifications on any of the RFP documents no later than the date indicated in Section 3: Data Sheet. Any request for clarification must be sent in writing in the

	manner indicated in Section 3: Data Sheet. Explanations or interpretations provided by personnel other than the named contact person will not be considered binding or official.
	IOM will provide the responses to clarifications through the method specified in Section 3: Data Sheet.
	IOM shall endeavour to provide responses to clarifications in an expeditious manner, but any delay in such response shall not cause an obligation on the part of IOM. to extend the submission date of the proposals, unless IOM deems that such an extension is justified and necessary.
8. Amendment of solicitation documents	At any time prior to the deadline for proposal submission, IOM may for any reason, such as in response to a clarification requested by a proposer, modify the RFP in the form of an amendment to the RFP. Amendments will be made available to all prospective proposers.
	If the amendment is substantial, IOM may extend the deadline for submission of proposals to give the proposers reasonable time to incorporate the amendment into their proposal.
PREPARATION OF PROPOSALS	
9. Cost of preparation of proposal	The proposer shall bear all costs related to the preparation and/or submission of the proposal, regardless of whether its proposal is selected or not. IOM shall not be responsible or liable for those costs, regardless of the conduct or outcome of the procurement process.
10. Language	The proposal, as well as any and all related correspondence, exchanged by the proposer and IOM, shall be written in the language(s) specified in Section 3: Data Sheet.
11. Documents establishing eligibility and qualifications of the proposer	The proposer shall furnish documentary evidence of its status as an eligible and qualified vendor, using the forms provided in Section 7 and providing the documents required in those forms. In order to award a contract to a proposer, its qualifications must be documented to IOM's satisfaction.
12. Technical proposal format and content	The proposer is required to submit a technical proposal using the forms provided in Section 7 and taking into consideration the requirements in the RFP.
	The technical proposal shall not include any price or financial information. A technical proposal containing material financial information may be declared non-responsive.
13. Financial proposal	The financial proposal shall be prepared using the form provided in Section 7 and taking into consideration the requirements in the RFP. It shall list all major cost components associated with the services, and the detailed breakdown of such costs.
	Any output and activities described in the technical proposal but not priced in the financial proposal, shall be assumed to be included in the prices of other activities or items as well as in the final total price.
	Prices and other financial information must not be disclosed in any other place except in the financial proposal.
14. Currencies	All prices shall be quoted in the currency or currencies indicated in Section 3: Data Sheet. Where proposals are quoted in different currencies, for the purposes of comparison of all proposals:
	IOM will convert the currency quoted in the proposal into the IOM preferred currency, in accordance with the IOM Operational Rate of Exchange on the date of the bid closure.
	• In the event that IOM selects a proposal for an award that is quoted in a currency different from the preferred currency in Section 3: Data Sheet, IOM shall reserve the right to award the contract in the currency of IOM's preference, using the conversion method specified above.



## 15. Duties and taxes The International Organization for Migration is exempt from all direct taxes, except charges for public utility services, and is exempt from customs restrictions, duties, and charges of a similar nature in respect of articles imported or exported for its official use. All quotations shall be submitted net of any direct taxes and any other taxes and duties. All proposals shall be submitted net of any direct taxes and any other taxes and duties unless otherwise specified in Section 3: Data Sheet 16. Proposal validity period Proposals shall remain valid for the period specified in Section 3: Data Sheet, commencing on the deadline for submission of proposals. A proposal valid for a shorter period may be rejected by IOM and rendered non-responsive. During the proposal validity period, the proposer shall maintain its original proposal without any change, including the availability of the key personnel, the proposed rates and the total price. In exceptional circumstances, prior to the expiration of the proposal validity period, IOM may request proposers to extend the period of validity of their proposals. The request and the responses shall be made in writing and shall be considered integral to the proposal. If the proposer agrees to extend the validity of its proposal, it shall be done without any change to the original proposal but will be required to extend the validity of the proposal security, if required, for the period of the extension, and in compliance with Article 17 (Proposal security) in all respects. The proposer has the right to refuse to extend the validity of its proposal without forfeiting the proposal security, if required, in which case, the proposal shall not be further evaluated. 17. Proposal security Proposal Security is not required under this RFP. 18. Joint Venture. If the proposer is a group of legal entities that will form or have formed a Joint Venture (JV), Consortium Consortium or Association for the proposal, each such legal entity will confirm in their joint Association proposal that: they have designated one party to act as a lead entity, duly vested with authority to legally bind the members of the JV, Consortium or Association jointly and severally, and this will be evidenced by a duly notarised agreement among the legal entities, which will be submitted along with the proposal; and if they are awarded the contract, the contract shall be entered into by and between IOM. and the designated lead entity, who will be acting for and on behalf of all the member entities comprising the joint venture. After the deadline for submission of proposal, the lead entity identified to represent the JV, Consortium or Association shall not be altered without the prior written consent of IOM. If a JV, Consortium or Association's proposal is the proposal selected for award, IOM. will award the contract to the joint venture, in the name of its designated lead entity. The lead entity will sign the contract for and on behalf of all other member entities. The lead entity and the member entities of the JV, Consortium or Association shall abide by the provisions of Article 19 (Only one Proposal) herein in respect of submitting only one proposal. The description of the organization of the JV, Consortium or Association must clearly define the expected role of each of the entities in the joint venture in delivering the requirements of the RFP, both in the proposal and the JV, Consortium or Association Agreement. All entities that comprise the JV, Consortium or Association shall be subject to the eligibility and qualification assessment by IOM.



	A JV, Consortium or Association, in presenting its track record and experience, should clearly differentiate between:
	Those that were undertaken together by the JV, Consortium or Association; and
	Those that were undertaken by the individual entities of the JV, Consortium or Association.
	Previous contracts completed by individual experts working privately but who are permanently or were temporarily associated with any of the member firms cannot be claimed as the experience of the JV, Consortium or Association or those of its members, but should only be claimed by the individual experts themselves in their presentation of their individual credentials.
	JV, Consortium or Associations are encouraged for high value, multi-sectoral requirements when the spectrum of expertise and resources required may not be available within one firm.
19. Only one proposal	The proposer (including the individual members of any Joint Venture) shall submit only one proposal, either in its own name or as part of a Joint Venture.
	Proposals submitted by two (2) or more proposers shall all be rejected if they are found to have any of the following:
	they have at least one controlling partner, director, or shareholder in common; or
	<ul> <li>any one of them receive or have received any direct or indirect subsidy from the other/s; or</li> </ul>
	<ul> <li>they have the same legal representative for purposes of this RFP; or</li> </ul>
	<ul> <li>they have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence the proposal of another proposer regarding this RFP process;</li> </ul>
	<ul> <li>they are subcontractors to each other's proposal, or a subcontractor to one proposal also submits another proposal under its name as lead proposer, or some key personnel proposed to be in the team of one proposer participates in more than one proposal received for this RFP process. This condition relating to the personnel does not apply to subcontractors being included in more than one proposal.</li> </ul>
20. Alternative proposals	Unless otherwise specified in Section 3: Data Sheet, alternative proposals shall not be considered. If submission of alternative proposals is allowed in Section 3: Data Sheet, a
	proposer may submit an alternative proposal, but only if it also submits a proposal conforming to the RFP requirements. Where the conditions for its acceptance are met, or justifications are clearly established, IOM reserves the right to award a contract based on an alternative proposal.
	If multiple/alternative proposals are being submitted, they must be clearly marked as "Main Proposal" and "Alternative Proposal". If no indication is provided as to which proposal is the main proposal and which is/are the alternative proposal(s), then all proposals will be rejected.
21. Pre-proposal conference	When appropriate, a pre-proposal conference will be conducted at the date, time and location and according to any instructions specified in Section 3: Data Sheet.
	If it is stated in Section 3: Data Sheet that the pre-proposal conference is mandatory, a Proposer which does not attend the pre-proposal conference shall become ineligible to submit a proposal under this RFP.
	If it is stated in Section 3: Data Sheet that the pre-proposal conference is not mandatory, non-attendance shall not result in disqualification of an interested proposer.



	IOM will not issue any formal answers to questions from proposers regarding the RFP or proposal process during the pre-proposal conference. All questions shall be submitted in accordance with Article 38 (Clarification of Proposals).
	The pre-proposal conference shall be conducted for the purpose of providing background information only. Without limiting Article 24 (Proposers responsibility) proposers shall not rely upon any information, statement or representation made at the pre-proposal conference unless that information, statement or representation is confirmed by Michael McCormack, Senior Procurement and Logistics Assistant, in writing.
	Minutes of the pre-proposal conference will be disseminated as specified in Section 3: Data Sheet. No verbal statement made during the conference shall modify the terms and conditions of the RFP, unless specifically incorporated in the minutes of the proposer's conference or issued/posted as an amendment to RFP.
22. Site inspection	A site inspection will not be required under this RFP
23. Errors or omissions	Proposers shall immediately notify IOM in writing of any ambiguities, errors, omissions, discrepancies, inconsistencies or other faults in any part of the RFP, with full details of those ambiguities, errors, omissions, discrepancies, inconsistencies or other faults.
	Proposers shall not benefit from such ambiguities, errors, omissions, discrepancies, inconsistencies or other faults.
24. Proposers responsibility to inform	Proposers shall be responsible for informing themselves in preparing their proposal. In this regard, proposers shall ensure that they:
themselves	<ul> <li>examine and fully inform themselves in relation to all aspects of the RFP, including the Contract and all other documents included or referred to in this RFP;</li> </ul>
	review the RFP to ensure that they have a complete copy of all documents;
	obtain and examine all other information relevant to the project and the scope of the requirements available on reasonable inquiry;

	Proposers acknowledge that IOM, its directors, employees and agents make no representations or warranties (express or implied) as to the accuracy, currency or completeness of this RFP or any other information provided to the proposers.
25. No material change(s	The proposer shall inform IOM of any change(s) of circumstances arising during the RFP process, including but not limited to:
	a change affecting any declaration, accreditation, license or approval;
	<ul> <li>major re-organizational changes, company re-structuring, a take-over, buy-out or similar event(s) affecting the operation and/or financing of the proposer or its major sub-contractors;</li> </ul>
	a change to any information on which IOM may rely in assessing proposals.



SUBMISSION AND OPENING OF PROPOSALS			
26. Instruction for proposal submission	The proposer shall submit a complete proposal in the format and comprising the documents and forms in accordance with requirements in Section 3: Data Sheet. The proposal shall be delivered according to the method specified in Section 3: Data Sheet.		
	The proposal shall be signed by the proposer or person(s) duly authorized to commit the proposer. The authorization shall be communicated through a document evidencing such authorization issued by the legal representative of the proposing entity, or, if requested, a Power of Attorney, accompanying the proposal.		
	Proposers must be aware that the mere act of submission of a proposal, in and of itself, implies that the proposer fully accepts the IOM General Conditions of Contract.		
27. Deadline for proposal submission	Complete proposals must be received by IOM in the manner, and no later than the date and time, specified in Section 3: Data Sheet. If any doubt exists as to the time zone in which the Proposal should be submitted, refer to <a href="http://www.timeanddate.com/worldclock/">http://www.timeanddate.com/worldclock/</a> . It shall be the sole responsibility of the proposers to ensure that their proposal is received by the closing date and time. IOM shall accept no responsibility for proposals that arrive late due to the courier company or any technical issues and shall only recognise the actual date and time that the proposal was received by IOM.		
	IOM may, at its discretion, extend this deadline for the submission of proposals by amending the solicitation documents in accordance with Article 8 (Amendment of solicitation documents). In this case, all rights and obligations of IOM and proposers subject to the previous deadline will thereafter be subject to the new deadline as extended.		
28. Withdrawal, substitution and modification of proposals	A proposer may withdraw, substitute or modify its proposal after it has been submitted at any time prior to the deadline for submission by sending a written notice to IOM, duly signed by an authorized representative and shall include a copy of the authorization (or a Power of Attorney). The corresponding substitution or modification of the proposal, if any, must accompany the respective written notice. All notices must be submitted in the same manner as specified for submission of proposals, by clearly marking them as "WITHDRAWAL", "SUBSTITUTION" OR "MODIFICATION".		
	However, after the deadline for proposal submission, the proposals shall remain valid and open for acceptance by IOM for the entire proposal validity period, as may be extended.		
	Proposals requested to be withdrawn prior to the deadline for submission of the proposals shall be made available for collection by the proposer that submitted it within 15 days of its withdrawal. Otherwise, IOM shall have the right to discard such proposal unopened without further notice to the proposer. IOM shall not be responsible to return the proposal to the proposer at IOM's cost.		
29. Storage of proposals	Proposals received prior to the deadline of submission and the time of opening shall be securely kept unopened until the proposal opening date stated in Section 3: Data Sheet. No responsibility shall be attached to IOM for prematurely opening an improperly addressed and/or identified proposal.		
30. Proposal opening	Proposals will be opened by an ad-hoc panel consisting of at least two staff members and where at least one individual is not involved in the subsequent stages of the procurement process.		
	There will be separate proposal openings for technical and financial proposals.		
	The proposers' names and submitted documents shall be announced and recorded on the technical proposal opening report, which will be available for viewing only to proposers who have submitted a proposal for a period of thirty days from the date of opening. Information not included in the proposal opening report will not be provided to proposers.

	Once the technical evaluation has been completed, the financial proposals will be opened.
	During the financial proposal opening, the proposers' names and the prices stated in the
	financial proposal shall be announced and recorded on the financial proposal opening report.
	No proposal shall be rejected during proposal opening, except for late proposals.
31. Late proposals	Any proposal received by IOM after the deadline for submission of proposals will be destroyed
	unless the proposer requests that it be returned and assumes the responsibility and expenses
	for the re-possession of the returned proposal documents.
	In exceptional circumstances, late proposals may be accepted if it is determined that the
	submission was sent in ample time prior to the proposed closing and the delay could not be
	reasonably foreseen by the proposer or was due to force majeure.
EVALUATION OF PROPOSALS	
32. Confidentiality	Information relating to the examination, evaluation, and comparison of proposals, and
	the recommendation of contract award, shall not be disclosed to proposers or any other
	persons not officially concerned with such process, even after publication of the contract
	award.
	Any effort by a proposer or anyone on behalf of the proposer to influence IOM in the
	examination, evaluation and comparison of the proposals or contract award decisions may, at
	IOM's decision, result in the rejection of its proposal and may subsequently be subject to the application of prevailing IOM's vendor sanctions procedures.
33. Evaluation of proposals	IOM shall evaluate a proposal using only the methodologies and criteria defined in this RFP.  No other criteria or methodology shall be permitted.
	IOM shall conduct the evaluation solely on the basis of the submitted technical and financial proposals.
	Evaluation of proposals shall be undertaken in the following steps:
	a) Preliminary examination
	b) Evaluation of minimum eligibility and qualification (if pre-qualification is not done)
	c) Evaluation of technical proposals
	d) Evaluation of financial proposals.
34. Preliminary	IOM shall examine the proposals to determine whether they are complete with respect to
examination	minimum documentary requirements, whether the documents have been properly signed,
	and whether the proposals are generally in order, among other indicators that may be used at
	this stage. IOM reserves the right to reject any proposal at this stage.
35. Evaluation of eligibility	The eligibility and qualification of the proposer will be evaluated against the minimum
and qualification	eligibility and qualification requirements specified in Section 4: Evaluation Criteria and in
	Article 4 (Eligible proposers).
36. Evaluation of technical	The evaluation team shall review and evaluate the technical proposals on the basis of their
and financial proposals	responsiveness to the Terms of Reference and other RFP documents, applying the evaluation
	criteria, sub-criteria, and point system specified in Section 4: Evaluation Criteria. A proposal
	shall be rendered non-responsive at the technical evaluation stage if it fails to achieve the
	minimum technical score indicated in Section 3: Data Sheet. When necessary, and if stated in the Data Sheet, IOM may invite technically responsive proposers for a presentation related to
	their technical proposals. The conditions for the presentation shall be provided in the proposal
	document where required.
	· ·



In the second stage, only the financial proposals of those proposers who achieve the minimum technical score will be opened for evaluation.

The evaluation method that applies for this RFP shall be as indicated in Section 3: Data Sheet, which may be either of two (2) possible methods, as follows: (a) the lowest priced method which selects the lowest evaluated financial proposal of the technically responsive Proposers; or (b) the combined scoring method which will be based on a combination of the technical and financial score.

When the Data Sheet specifies a **combined scoring method**, the formula for the rating of the proposals will be as follows:

#### Rating the Technical Proposal (TP):

TP Rating = (Total Score Obtained by the Offer / Max. Obtainable Score for TP) x 100

#### Rating the Financial Proposal (FP):

FP Rating = (Lowest Priced Offer / Price of the Offer Being Reviewed) x 100

#### **Total Combined Score:**

**Combined Score** = (TP Rating) x (Weight of TP - 70%) + (FP Rating) x (Weight of FP - 30%)

#### 37. Post-qualification

IOM reserves the right to undertake a post-qualification assessment, aimed at determining, to its satisfaction, the validity of the information provided by the proposer. Such exercise shall be fully documented and may include, but need not be limited to, all or any combination of the following:

- a) Verification of accuracy, correctness and authenticity of information provided by the proposer;
- b) Validation of extent of compliance to the RFP requirements and evaluation criteria based on what has so far been found by the evaluation team;
- Inquiry and reference checking with Government entities with jurisdiction on the proposer, or with previous clients, or any other entity that may have done business with the proposer;
- d) Inquiry and reference checking with previous clients on the performance on ongoing or completed contracts, including physical inspections of previous works, as deemed necessary;
- e) Physical inspection of the proposer's offices, branches or other places where business transpires, with or without notice to the proposer;
- f) Other means that IOM may deem appropriate, at any stage within the selection process, prior to awarding the contract.

# 38. Clarification proposals

IOM may request clarification or further information in writing from the proposers at any time during the evaluation process. The proposers' responses shall not contain any changes regarding the substance or price of the proposal, except to confirm the correction of arithmetic errors discovered by IOM in the evaluation of the proposals, in accordance with

Instructions to Proposers Article 23 (Errors or omissions).

IOM may use such information in interpreting and evaluating the relevant proposal but is under no obligation to take it into account.

		Any unsolicited clarification submitted by a proposer in respect to its proposal which is not a response to a request by IOM, shall not be considered during the review and evaluation of the proposals.
39.	Responsiveness of proposal	IOM's determination of a proposal's responsiveness is to be based on the contents of the proposal itself. A substantially responsive proposal is one that conforms to all the terms, conditions, TOR and other requirements of the RFP without material deviation, reservation, or omission. A material deviation, reservation, or omission is one that:
		a) affects in any substantial way the scope, quality, or performance of the services specified in the contract; or
		b) limits in any substantial way, inconsistent with the solicitation documents, IOM's rights or the proposer's obligations under the contract; or
		c) if rectified would unfairly affect the competitive position of other proposers presenting substantially responsive proposals.
		If a proposal is not substantially responsive, it shall be rejected by IOM. and may not subsequently be made responsive by the proposer by correction of the material deviation, reservation, or omission.
40.	Nonconformities, reparable errors and omission	Provided that a proposal is substantially responsive, IOM may waive any non-conformities or omissions in the proposal that, in the opinion of IOM, do not constitute a material deviation. These are a matter of form and not of substance and can be corrected or waived without being prejudicial to other proposers.
		Provided that a proposal is substantially responsive IOM may request the proposer to submit the necessary information or documentation, within a reasonable period, to rectify nonmaterial nonconformities or omissions in the proposal related to documentation requirements. ## Airport-based Assistances and Payment Services on the basis of Long-Term Agreement (LTA)

Operational and Financial Assistances within the Framework of Return and Resettlement Programmes to and from Germany

## A. Background and General Considerations

#### 1. Background

Established in 1951, IOM is the leading inter-governmental organization in the field of migration and works closely with governmental, intergovernmental and nongovernmental partners.

With 175 member states, a further 8 states holding observer status and operating in over 500 locations, IOM is dedicated to promoting humane and orderly migration for the benefit of all. It does so by providing services and advice to governments and migrants.

IOM works to help ensure the orderly and humane management of migration, to promote international cooperation on migration issues, to assist in the search for practical solutions to migration problems and to provide humanitarian assistance to migrants in need, including refugees and internally displaced people.

Since September 2016 IOM is part of the United Nations system as a related organization.

The Federal Republic of Germany has been a member of IOM since 1954. IOM staff in Berlin, Nuremberg, Rhineland-Palatine and Bremerhaven implement in cooperation with governmental and non-governmental partners projects in the area of migration.

The IOM mission in Berlin is also the liaison office for cooperation on migration international IOM projects in the areas of humanitarian aid, peacebuilding and combatting human trafficking, which are supported by the German government.

#### Resettlement, Relocation and Humanitarian Admission

A significant part of the movement operations of IOM worldwide happens in the frameworks of Resettlement programs. IOM Germany facilitates the Resettlement, Relocation and Humanitarian Admission in the frame of several different projects. Refugee resettlement is defined by UNHCR as "the selection and transfer of refugees from a state in which they have sought protection to a third country that admits them — as refugees — with a permanent residence status", relocation enables those who requested asylum in one EU Member State to travel to another EU Member State, where their asylum application will be further processed. In situations of war and crisis, a humanitarian admission is an important protection tool ensuring the admission of beneficiaries of a particular nationality or group to Germany in a timely manner and ensuring protection.

For Resettlement efforts to the United States, IOM is, for example, partnering with the United States and supporting the resettlement of beneficiaries under the United States Refugee Admissions Program (USRAP), advancing the United States policy objective of promoting safe, humane, and orderly migration. For Resettlement to Canada, IOM is facilitating movements in close coordination with Canadian embassies as well as Immigration, Refugees and Citizenship Canada.



IOM also facilitates different Federal and State programs regarding the implementation of Resettlement, Relocation and Humanitarian Admissions programmes to Germany.

#### **REAG/GARP Programme**

The International Organization for Migration assists migrants who voluntarily return to their home countries or migrate to a receptive third country, by providing logistical and financial support as well as tailored assistance to migrants in vulnerable situations.

In 1979, the German Ministry for Family, Youth and Health gave IOM the authority to implement the Reintegration and Emigration Program for Asylum-Seekers in Germany – REAG¹ Programme. In 1989, the program was then complemented by the Government Assisted Repatriation Program – GARP² Programme, which was initiated as a supporting measure and financed by the Ministry of the Interior. Effective from 1st January 2000, the Ministry of the Interior took over the entire responsibility for both programs. As of 2010, the European Return Fund participates as part of the Project "Nationwide financial assistance to voluntary returnees" in the funding of the program. The REAG/GARP-Program is implemented by IOM on behalf of the Ministry of Interior (MOI) and the respective German Federal States' ministries, who jointly finance the program. Co-funding by the European Return Fund for the Project "Nationwide financial assistance to voluntary returnees" has been requested since 2013.

The REAG/GARP-program is a humanitarian program assisting with financial and operational support the voluntary return and migration to third countries. It offers start-up assistance for defined nationalities and serves as a steering instrument for migration movements. The migrants eligible to benefit from the program are asylum seekers, rejected asylum-seekers and recognized refugees as well as war and civil-war refugees, victims of forced prostitution or trafficking and other foreigners (eligible under § 1 AsylblG, the German asylum seekers' benefit Act), as well as migrants who have been granted residence due to humanitarian or political reasons.

The application of financial assistance within the program REAG/GARP is organized in cooperation with German authorities, welfare organizations, specialized counselling centers, central information centers for voluntary return,

Within the framework of the program, the German Government grants the following types of assistance:

- Coverage of travel costs (e.g. by plane or bus);
- Additional travel assistance (upon departure, in transit and/or upon arrival);
- Pocket money for the return journey;
- Initial start-up cash to beneficiaries of various countries of origin;
- Tailored assistance for migrants in vulnerable situations.

Since the beginning of this program, IOM Germany has assisted almost 750,000 people to voluntarily return to their home countries or emigrate to a third country. Further information on the program and voluntary return in general is available on the information portal *ReturningFromGermany*.

## B. Scope of Services, Expected Outputs and Performance Standards

### 1. Objective

IOM is hereby undertaking a solicitation of proposals from service providers who are interested to provide airport-based payments of financial assistances and operational support for migrants at the airports within the frame of Return and Resettlement programmes to and from Germany. All management and administrative products, current and emerging, which assist in the support of this service, fall within the scope of the proposal.

#### 2. Scope of Services and Expected Outputs

The successful Service Provider shall provide full, prompt and accurate cash payments to specified IOM beneficiaries and comprehensive, timely assistance to specified IOM beneficiaries.

As outlined in the programme description, beneficiaries will be paid financial grants and will receive airport assistance at the following airports:

- Frankfurt am Main (FRA)
- Munich (MUC)
- Dusseldorf (DUS)
- Hamburg (HAM)
- Berlin (BER)

The total yearly amount of the financial assistances cannot be specified in advance. The following estimates informed by previous years are provided as a reference guide:

#### The following tasks are required:

#### i. Scheduling and employee deployment plan

Prior to any financial assistance being paid and/or airport assistances provided at a respective airport, the responsible IOM staff will inform the Service Provider of the type of the financial assistance, amount and time of payment and/or the type of operational assistance at least 3 working days in advance. The schedule is according to flight time of the movement. One day prior to the scheduled flight date of the movement, IOM will send an overview of the planned movements including name of beneficiaries, flight details, types of requested financial and operational assistances including due amounts. In the event of cancellations, rescheduling of flights, changes of departure gates and other unforeseen circumstances IOM will notify the Service Provider by issuing an updated overview. This must be considered when preparing the day's employee deployment plan. To guarantee timely payments and provision of assistances for each individual movement, irrespective of the airport, the flight day/time must be monitored individually. This includes movement and payments on weekends and public holidays, and it must be taken into account in the employee deployment plan. IOM will ensure that the beneficiaries are informed where and when to collect the financial assistance and to meet staff for airport assistances. The operational coordination of the payments including training of employees, is the responsibility of the Service Provider.



#### ii. Provision of cash at respective airports

The provision and availability of sufficient cash at all airports (Frankfurt/Main, Munich, Dusseldorf, Hamburg and Berlin) is the responsibility of the Service Provider. It is to be noted that the cash withdrawals in the needed amounts might not be available at all airports. The arrangements hereto are also in the responsibility of the Service Provider. Administrative fee, transaction costs and any other fees hereto are to be covered by the Service Provider.

#### iii. Contact with airlines at each airport

In case of any difficulties arising before departure (e.g. overbooking, booking inexistent with the airline, difficulties with issuing tickets due to different names recorded, necessary changes due to missed connections, etc.), the Service Provider will act as intermediary contact between IOM and the beneficiaries on site.

### iv. Payment procedure to the departing returnees

- \* After receiving an **IOM entitlements confirmation form** for each case and the list of beneficiaries including the time of the financial entitlements and the respective amounts, the indicated amount shall be prepared in cash for each case and held ready for disbursement on site.
- \* The Service Provider will meet the beneficiaries at the departure gate **one hour** before departure. The bio data including the number of beneficiaries per case will be compared with the provided information in the IOM confirmation form and the beneficiaries original travel documents.
- \* The amount indicated in the IOM entitlement confirmation form is the amount payable to beneficiaries. The receipt of the paid amount must be acknowledged by the principle applicant by his/her signature of acknowledgement on the receipt of entitlement form. The form shall be also signed and stamped by the Service Provider. Depending on the type of the financial assistance, it might be necessary that beneficiaries acknowledge receipt of assistances by signing more than one document.
- \* The Service Provider has to guarantee that non-refundable direct and indirect expenses incurred due to the non-satisfactory performance of the Service Provider, such as, but not limited to the case of missing or incomplete original documents, missing signatures or signature of the wrong person, will be reimbursed by the Service Provider.

### v. Provision of airport assistances

Specified IOM beneficiaries will receive (1) departure assistance from Check-in to the departure gate, including assistance with border control as well as security check. In exceptional cases, the meeting point with the beneficiaries will be the train station or the taxi stand. The service provider will meet the specified beneficiaries 2 hours prior to departure time at the Check-in or a designated meeting point in the airport.

Specified IOM beneficiaries will receive (2) arrival assistance from arrival gate to onward transportation, such as bus or train. The service provider will meet the specified beneficiaries upon arrival and assist with passport control as well as baggage pick up as well as handing over of responsibility to receiving parties.

#### vi. <u>6. Additional services</u>

- \* Support service for persons with special needs.
- \* When required, the supervision of persons with flight cancellations in the transit area of the airport until the new departure date.
- \* In cooperation with the border police and IOM, provide any other general assistance required, especially in case of unexpected circumstances.

## C. Contractual and Institutional Arrangements

#### 1. Contract Parameters

IOM envisages entering into an agreement with one or more selected Service Providers for the provision of airport cash payments and operational assistances at airports throughout Germany. The initial period of the contract will be one year with the option to extend for two additional years, subject to a satisfactory performance evaluation and requirements of IOM.

For the services listed under sub-section B (Scope of Services, Expected Outputs and Performance Standards) of the Terms of Reference the selected Service Provider will charge the IOM on fixed transaction fee as detailed in Price Schedule Form of the present Request for Proposal. The level of the service fees shall remain fixed for the whole duration of the contract and shall apply per IOM case number.

## 2. Contract Management and Billing

The IOM shall, from time to time, evaluate and verify with other Service Providers and other industry indicators the comparability and competitiveness of the rates offered by the contracted company. The IOM reserves the right to terminate contract with the Service Provider at any time if the Service Provider charges IOM on higher rates than agreed or does not render minimum services described in this tendering document.

#### **Billing and Invoice**

The Service Provider must prepare a monthly statement and reports of activities and together with the original signed entitlement receipts send them in regular intervals to IOM. These will be checked for consistency and serve as a base for reimbursement of occurred expenses and agreed fees.



## D. Qualifications of the Successful Service Provider

#### Qualification of the Successful Service Provider

The successful Service Provider which will be contracted to serve the needs of the IOM shall have the following minimum eligibility criteria:

- Existence of an airport licence with an office/counter at the respective airport serving as a contact point, including for the forwarding of payment orders
- Identification/authority to enter the security area of the airport
- Proof of liquidity
- Availability of staff for proper performance of the required services
- Police clearance certificate from all persons handling cash for payment distribution
- Employees with intercultural competence and language skills
- Experience in dealing with particularly vulnerable persons (e.g. persons with health concerns, traumatized persons, persons with a handicap)
- The Service Provider has to guarantee that non-refundable direct and indirect expenses incurred due to the non-satisfactory performance of the Service Provider, such as, but not limited to the case of missing or incomplete original documents, missing signatures or signature of the wrong person, will be reimbursed by the Service Provider;

The successful Service Provider shall be required to devote personnel with the following minimum qualifications:

- 1. One Client Manager should be assigned to be responsible for overall payment management coordination with IOM. The Client Manager with adequate authority to make decisions for the timely resolution of problems;
- 2. At least two staff experts with a minimum 5 five years of practical experience in the management of airport services.

The nominated staff experts in the proposal must be the employee who will be responsible for the management of payment requests to IOM the entire period set for this contract. If the airport expert decided to terminate her/his services with the Service Provider, the latter must notify IOM one month in advance

The Service Provider shall have a contingency replacement plan to be enforced during periods of illness and vacations of its personnel in order to maintain full service at all times under the contract.



#### **SECTION 6: CONDITIONS OF CONTRACT AND CONTRACT FORMS**

6.1 Contract Form with General Conditions of Contract

This Service Agreement is entered into by the **International Organization for Migration**, a related organization of the United Nations, acting through its Mission in Germany, Charlottenstr 68. 10117, Berlin, represented by Jean-Philippe Chauzy, Chief of Mission, hereinafter referred to as "**IOM**," and **[Name of the Service Provider**], [Address], represented by [Name, Title of the representative of the Service Provider], hereinafter referred to as the "**Service Provider**." IOM and the Service Provider are also referred to individually as a "**Party**" and collectively as the "**Parties**."

#### 1. Introduction and Integral Documents

- 1.1 The Service Provider agrees to provide IOM with **Airport-Based Assistances and Payment Services** in accordance with the terms and conditions of this Agreement and its Annexes, if any.
- 1.2 The following documents form an integral part of this Agreement:
  - (a) Annex A –Terms of reference
  - (b) Annex B Price Schedule
  - (c) Annex C IOM's Data Protection Principles

In the event of conflict between the provisions of any Annex and the terms of the main body of the Agreement, the latter shall prevail.

#### 2. Services

2.1 The Service Provider agrees to provide to the IOM the following services (the "Services"):

In accordance with Terms of Reference listed under Annex A of agreement, provision of Airport-based Assistance and Payment Services for IOM beneficiaries at airports listed under Annex A.



- 2.2 The Service Provider shall commence the provision of Services from **1 September 2023** and fully and satisfactorily complete them by **31 August 2024**.
- 2.3 The Service Provider agrees to provide the Services required under this Agreement in strict accordance with the specifications of this Article and any attached Annexes.
- 2.4 If any United Nations ("UN") entity wishes to avail of services which are of the same type as the Services through their own contracting formats, the Service Provider shall extend such services to them at prices and on terms no less favourable than those provided in this Agreement for the Services. For this purpose, IOM shall be entitled to disclose information related to this Agreement to any other UN entity.

#### 3. The Service Fee

- 3.1 The Service fee for the Services under this Agreement shall be equivalent to the rates indicated in the Price Schedule (Annex B), based on the actual Services provided as per IOM's request.
- 3.2 The Service Provider shall invoice IOM upon completion of all the Services on a monthly basis. The invoice shall include all required supporting documents including Transit Statement for month which invoice is issued.
- 3.3 The Service Fee shall become due 30 (days) days after IOM's receipt and approval of the invoice.
- 3.4 Payment shall be made in EURO by bank transfer to the following bank account:

- 3.5 The Service Provider shall be responsible for the payment of all taxes, duties, levies and charges assessed on the Service Provider in connection with this Agreement.
- 3.6 IOM shall be entitled, without prejudice to any other rights or remedies it may have, to withhold payment of part or all of the Service Fee until the Service Provider has completed to the satisfaction of IOM the Services to which those payments relate.



#### 4. Warranties

#### 4.1 The Service Provider warrants that:

- (a) It is a company financially sound and duly licensed, with adequate human resources, equipment, competence, expertise and skills necessary to provide fully and satisfactorily, within the stipulated completion period, all the Services in accordance with this Agreement;
- (b) It shall comply with all applicable laws, ordinances, rules and regulations when performing its obligations under this Agreement;
- (c) In all circumstances it shall act in the best interests of IOM;
- (d) No official of IOM or any third party has received from, will be offered by, or will receive from the Service Provider any direct or indirect benefit arising from the Agreement or award thereof:
- (e) It has not misrepresented or concealed any material facts in the procurement of this Agreement;
- (f) The Service Provider, its staff or shareholders have not previously been declared by IOM ineligible to be awarded agreements by IOM;
- (g) It has or shall take out relevant insurance coverage for the period the Services are provided under this Agreement;
- (h) The Price specified in this Agreement shall constitute the sole remuneration in connection with this Agreement. The Service Provider shall not accept for its own benefit any trade commission, discount or similar payment in connection with activities pursuant to this Agreement or the discharge of its obligations thereunder. The Service Provider shall ensure that any subcontractors, as well as the personnel and agents of either of them, similarly, shall not receive any such additional remuneration;
- (i) It shall respect the legal status, privileges and immunities of IOM as an intergovernmental organization, such as inviolability of documents and archive wherever it is located, exemption from taxation, immunity from legal process or national jurisdiction. In the event that the Service Provider becomes aware of any situation where IOM's legal status, privileges or immunities are not fully respected, it shall immediately inform IOM;
- (j) It is not included in the most recent Consolidated United Nations Security Council Sanctions List nor is it the subject of any sanctions or other temporary suspension. The Service Provider will disclose to IOM if it becomes subject to any sanction or temporary suspension during the term of this Agreement;
- (k) It must not employ, provide resources to, support, contract or otherwise deal with any person, entity or other group associated with terrorism as per the most recent Consolidated United Nations Security Council Sanctions List and all other applicable terrorism legislation. If, during the term of this Agreement, the Service Provider determines there are credible allegations that funds transferred to it in accordance with this Agreement have been used to provide support or assistance to individuals or entities associated with terrorism, it will inform IOM immediately who in consultation with the donors as appropriate, shall determine an appropriate response. The Service Provider shall ensure that this requirement is included in all subcontracts.
- 4.2 The Service Provider warrants that it shall abide by the highest ethical standards in the performance of this Agreement, which includes not engaging in any fraudulent, corrupt, discriminatory or exploitative practice or practice inconsistent with the rights set forth in the Convention on the Rights of the Child. The Service Provider shall immediately inform IOM of any suspicion that the following practice may have occurred or exist:



- a corrupt practice, defined as the offering, giving, receiving or soliciting, directly or indirectly, of anything of value to influence the action of IOM in the procurement process or in contract execution;
- (b) a fraudulent practice, defined as any act or omission, including a misrepresentation or concealment, that knowingly or recklessly misleads, or attempts to mislead, IOM in the procurement process or the execution of a contract, to obtain a financial gain or other benefit or to avoid an obligation or in such a way as to cause a detriment to IOM;
- (c) a collusive practice, defined as an undisclosed arrangement between two or more bidders designed to artificially alter the results of the tender process to obtain a financial gain or other benefit;
- a coercive practice, defined as impairing or harming, or threatening to impair or harm, directly or indirectly, any participant in the tender process to influence improperly its activities, or affect the execution of a contract;
- (e) an obstructive practice, defined as (i) deliberately destroying, falsifying, altering or concealing of evidence material to IOM investigations, or making false statements to IOM investigators in order to materially impede a duly authorized investigation into allegations of fraudulent, corrupt, collusive, coercive or unethical practices; and/or threatening, harassing or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation; or (ii) acts intended to materially impede the exercise of IOM's contractual rights of access to information;
- (f) any other unethical practice contrary to the principles of efficiency and economy, equal opportunity and open competition, transparency in the process and adequate documentation, highest ethical standards in all procurement activities.

#### 4.3 The Service Provider further warrants that it shall:

- (a) Take all appropriate measures to prohibit and prevent actual, attempted and threatened sexual exploitation and abuse ("SEA") by its employees or any other persons engaged and controlled by it to perform activities under this Agreement ("other personnel"). For the purpose of this Agreement, SEA shall include:
  - Exchanging any money, goods, services, preferential treatment, job opportunities
    or other advantages for sexual favours or activities, including humiliating or
    degrading treatment of a sexual nature; abusing a position of vulnerability,
    differential power or trust for sexual purposes, and physical intrusion of a sexual
    nature whether by force or under unequal or coercive conditions;
  - 2. Engaging in sexual activity with a person under the age of 18 ("child"), except if the child is legally married to the concerned employee or other personnel and <u>is over the age of majority or consent both in the child's country of citizenship and in the country of citizenship of the concerned employee or other personnel;</u>
- (b) Strongly discourage its employees or other personnel having sexual relationships with IOM beneficiaries;
- (c) Report timely to IOM any allegations or suspicions of SEA, and investigate and take appropriate corrective measures, including imposing disciplinary measures on the person who has committed SEA;
- (d) Ensure that the SEA provisions are included in all subcontracts;
- (e) Adhere to above commitments at all times.
- 4.4 The Service Provider expressly acknowledges and agrees that breach by the Service Provider, or by any of the Service Provider's employees, contractors, subcontractors or agents, of any provision contained in Articles 4.1, 4.2 or 4.3 of this Agreement constitutes a material breach of this Agreement and shall entitle IOM to terminate this Agreement immediately on written notice without liability. In the event that IOM determines, whether through an investigation or



otherwise, that such a breach has occurred then, in addition to its right to terminate the Agreement, IOM shall be entitled to recover from the Service Provider all losses suffered by IOM in connection with such breach.

#### 5. Assignment and Subcontracting

- 5.1 The Service Provider shall not assign or subcontract the activities under this Agreement in whole or in part, unless agreed in writing in advance by IOM. Any subcontract entered into by the Service Provider without approval in writing by IOM may be cause for termination of the Agreement.
- 5.2 Notwithstanding such written approval from IOM, the Service Provider shall not be relieved of any liability or obligation under this Agreement nor shall it create any contractual relation between any subcontractor and IOM. The Service Provider shall include in an agreement with a subcontractor all provisions in this Agreement that are applicable to a subcontractor, including relevant Warranties and Special Provisions. The Service Provider remains liable as a primary obligor under this Agreement, and it shall be directly responsible to IOM for any faulty performance under any subcontract. The subcontractor shall have no cause of action against IOM for any breach of the subcontract.

#### 6. Delays, Defaults and Force Majeure

- Time is of the essence in the performance of this Agreement. If the Service Provider fails to provide the Services within the times agreed to in the Agreement, IOM shall, without prejudice to other remedies under this Agreement, be entitled to deduct liquidated damages for delay. The amount of such liquidated damages shall be 0.1% of the value of the total Service Fee per day or part thereof up to a maximum of 10% of the Service Fee. IOM shall have the right to deduct such amount from the Service Provider's outstanding invoices, if any. Such liquidated damages shall only be applied when delay is caused solely by the default of the Service Provider. Acceptance of Services delivered late shall not be deemed a waiver of IOM's rights to hold the Service Provider liable for any loss and/or damage resulting therefrom, nor shall it act as a modification of the Service provider's obligation to perform further Services in accordance with the Agreement.
- 6.2 In case of failure by the Service Provider materially to perform under the terms and conditions of this Agreement, IOM may, after giving the Service Provider 30 days' written notice to perform and without prejudice to any other rights or remedies, terminate the Agreement with immediate effect without liability.
- 6.3 Neither Party will be liable for any delay in performing or failure to perform any of its obligations under this Agreement if such delay or failure is caused by force majeure, which means any unforeseeable and irresistible act of nature, any act of war (whether declared or not), invasion, revolution, insurrection, terrorism, blockade or embargo, strikes, Governmental or state restrictions, natural disaster, epidemic, public health crisis, and any other circumstances which are not caused by nor within the control of the affected Party.
- 6.4 As soon as possible after the occurrence of a force majeure event which impacts the ability of the affected Party to comply with its obligations under this Agreement, the affected Party will give



notice and full details in writing to the other Party of the existence of the force majeure event and the likelihood of delay. On receipt of such notice, the unaffected Party shall take such action as it reasonably considers appropriate or necessary in the circumstances, including granting to the affected Party a reasonable extension of time in which to perform its obligations. During the period of force majeure, the affected Party shall take all reasonable steps to minimize damages and resume performance.

6.5 IOM shall be entitled without liability to suspend or terminate the Agreement if the Service Provider is unable to perform its obligations under the Agreement by reason of force majeure. In the event of such suspension or termination, the provisions of Article 17 (Termination) shall apply.

#### 7. Independent Contractor

The Service Provider, its employees and other personnel as well as its subcontractors and their personnel, if any, shall perform all Services under this Agreement as an independent contractor and not as an employee or agent of IOM.

#### 8. Audit

The Service Provider agrees to maintain financial records, supporting documents, statistical records and all other records relevant to the Services in accordance with generally accepted accounting principles to sufficiently substantiate all direct and indirect costs of whatever nature involving transactions related to the provision of Services under this Agreement. The Service Provider shall make all such records available to IOM or IOM's designated representative at all reasonable times until the expiration of 7 (seven) years from the date of final payment, for inspection, audit, or reproduction. On request, employees of the Service Provider shall be available for interview.

#### 9. Confidentiality

- 9.1 All information which comes into the Service Provider's possession or knowledge in connection with this Agreement is to be treated as strictly confidential. The Service Provider shall not communicate such information to any third party without the prior written approval of IOM. The Service Provider shall comply with IOM Data Protection Principles in the event that it collects, receives, uses, transfers, stores or otherwise processes any personal data in the performance of this Agreement. These obligations shall survive the expiration or termination of this Agreement.
- 9.2 Notwithstanding the previous paragraph, IOM may disclose information related to this Agreement, such as the name of the Service Provider and the value of the Agreement, the title of the contract/project, nature and purpose of the contract/project, name and locality/address of the Service Provider and the amount of the contract/project to the extent as required by IOM's donors or in relation to IOM's commitment to any initiative for transparency and accountability of funding received by IOM in accordance with the policies, instructions and regulations of IOM.



## 10. Intellectual Property

All intellectual property and other proprietary rights including, but not limited to, patents, copyrights, trademarks, and ownership of data resulting from the performance of the Services shall be vested in IOM, including, without any limitation, the rights to use, reproduce, adapt, publish and distribute any item or part thereof.

#### 11. Notices

Any notice given pursuant to this Agreement will be sufficiently given if it is in writing and received by the other Party at the following address:

#### 12. Dispute Resolution

- 12.1. Any dispute, controversy or claim arising out of or in relation to this Agreement, or the breach, termination or invalidity thereof, shall be settled amicably by negotiation between the Parties.
- 12.2 In the event that the dispute, controversy or claim has not been resolved by negotiation within 3 (three) months of receipt of the notice from one party of the existence of such dispute, controversy or claim, either Party may request that the dispute, controversy or claim is resolved by conciliation by one conciliator in accordance with the UNCITRAL Conciliation Rules of 1980. Article 16 of the UNCITRAL Conciliation Rules does not apply.
- 12.3 In the event that such conciliation is unsuccessful, either Party may submit the dispute, controversy or claim to arbitration no later than 3 (three) months following the date of termination of conciliation proceedings as per Article 15 of the UNCITRAL Conciliation Rules. The arbitration will be carried out in accordance with the 2010 UNCITRAL arbitration rules as adopted in 2013. The number of arbitrators shall be one and the language of arbitral proceedings shall be English, unless otherwise agreed by the Parties in writing. The arbitral tribunal shall have no authority to award punitive damages. The arbitral award will be final and binding.



12.4 The present Agreement as well as the arbitration agreement above shall be governed by the terms of the present Agreement and supplemented by internationally accepted general principles of law for the issues not covered by the Agreement, to the exclusion of any single national system of law that would defer the Agreement to the laws of any given jurisdiction. Internationally accepted general principles of law shall be deemed to include the UNIDROIT Principles of International Commercial Contracts. Dispute resolution shall be pursued confidentially by both Parties. This Article survives the expiration or termination of the present Agreement.

#### 13. Use of IOM Name, Abbreviation and Emblem

The Service Provider shall not be entitled to use the name, abbreviation or emblem of IOM without IOM's prior written authorisation. The Service Provider acknowledges that use of the IOM name, abbreviation and emblem is strictly reserved for the official purposes of IOM and protected from unauthorized use by Article 6*ter* of the Paris Convention for the Protection of Industrial Property, revised in Stockholm in 1967 (828 UNTS 305 (1972)).

#### 14. Status of IOM

Nothing in or relating to the Agreement shall be deemed a waiver, express or implied, of any of the privileges and immunities of the International Organization for Migration as an intergovernmental organization.

## 15. Indemnity

The Service Provider shall at all times defend, indemnify, and hold harmless IOM, its officers, employees, and agents from and against all losses, costs, damages and expenses (including legal fees and costs), claims, suits, proceedings, demands and liabilities of any kind or nature to the extent arising out of or resulting from acts or omissions of the Service Provider or its employees, officers, agents or subcontractors, in the performance of this Agreement. IOM shall promptly notify the Service Provider of any written claim, loss, or demand for which the Service Provider is responsible under this clause. This indemnity shall survive the expiration or termination of this Agreement.

#### 16. Waiver

Failure by either Party to insist in any one or more instances on a strict performance of any of the provisions of this Agreement shall not constitute a waiver or relinquishment of the right to enforce the provisions of this Agreement in future instances, but this right shall continue and remain in full force and effect.



#### 17. Termination

- 17.1 IOM may at any time suspend or terminate this Agreement, in whole or in part, with immediate effect, by providing written notice to the Service Provider, in any case where the mandate of IOM applicable to the performance of the Agreement or the funding of IOM applicable to the Agreement is reduced or terminated. In addition, IOM may suspend or terminate the Agreement upon thirty (30) days' written notice without having to provide any justification.
- 17.2 In the event of termination of this Agreement, IOM will only pay for the Services completed in accordance with this Agreement, unless otherwise agreed in writing by the Parties. The Service Provider shall return to IOM any amounts paid in advance within 7 (seven) days from the notice of termination.
- 17.3 In the event of any termination of the Agreement, upon receipt of notice of termination, the Service Provider shall take immediate steps to bring the performance of any obligations under the Agreement to a close in a prompt and orderly manner, and in doing so, reduce expenses to a minimum, place no further subcontracts or orders for materials, services, or facilities, and terminate all subcontracts or orders to the extent they relate to the portion of the Agreement. Upon termination, the Service Provider shall waive any claims for damages including loss of anticipated profits on account thereof.
- 17.4 In the event of suspension of this Agreement, IOM will specify the scope of activities and/or deliverables that shall be suspended in writing. All other rights and obligations of this Agreement shall remain applicable during the period of suspension. IOM will notify the Service Provider in writing when the suspension is lifted and may modify the completion date. The Service Provider shall not be entitled to claim or receive any Service Fee or costs incurred during the period of suspension of this Agreement.

#### 18. Severability

If any part of this Agreement is found to be invalid or unenforceable, that part will be severed from this Agreement and the remainder of the Agreement shall remain in full force.

### 19. Entire Agreement

This Agreement embodies the entire agreement between the Parties and supersedes all prior agreements and understandings, if any, relating to the subject matter of this Agreement.

#### 20. Final Clauses

- 20.1 This Agreement will enter into force upon signature by both Parties. It will remain in force until completion of all obligations of the Parties under this Agreement unless terminated earlier in accordance with Article 17.
- 20.2 Amendments may be made by mutual agreement in writing between the Parties-
