APPLICATION BY THE REPUBLIC OF AZERBAIJAN
FOR MEMBERSHIP IN THE ORGANIZATION

1. In a letter dated 30 January 2001, the Republic of Azerbaijan applied for membership in the International Organization for Migration. A copy of the foregoing letter and of the Director General's reply, dated 9 February 2001, are annexed.
2. In accordance with Article 2 (b) of the Constitution, the Council is required to make a decision regarding the application of the Republic of Azerbaijan for membership and the rate of its contribution to the administrative requirements of the Organization, which the Director General recommends should be assessed at 0.050 per cent of the total contributions required from Member States to the Administrative part of the Budget.
3. An appropriate draft resolution will be submitted for consideration by the Council.

LETTER DATED 30 JANUARY 2001 FROM THE MINISTER
FOR FOREIGN AFFAIRS OF THE REPUBLIC OF AZERBAIJAN
ADDRESSED TO THE DIRECTOR GENERAL OF THE
INTERNATIONAL ORGANIZATION FOR MIGRATION

Sir,

I have the honour to refer to the relationship existing between the Government of the Republic of Azerbaijan and the International Organization for Migration (IOM).

My Government wishes to establish a closer relationship with your Organization and hereby applies for membership in the International Organization for Migration in accordance with Article 2, paragraph (b) of the IOM Constitution.

The Government of the Republic of Azerbaijan accepts the Constitution in accordance with its constitutional processes and the obligations resulting from membership. It also undertakes to make a financial contribution to the administrative requirements of the Organization, the rate of which will be agreed upon by the IOM Council and the Republic of Azerbaijan.

LETTER DATED 9 FEBRUARY 2001 FROM THE DIRECTOR GENERAL
OF THE INTERNATIONAL ORGANIZATION FOR MIGRATION TO THE
MINISTER FOR FOREIGN AFFAIRS OF THE REPUBLIC OF AZERBAIJAN

Sir,

I have the honour to acknowledge receipt of your letter dated 30 January 2001, ref. 044/N, in which you inform us that the Republic of Azerbaijan wishes to become a member of the International Organization for Migration (IOM), in accordance with Article 2, paragraph (b), of the Constitution.

I note that your Government accepts the Constitution in accordance with its constitutional processes and the obligations resulting from membership, and that it undertakes to make a financial contribution to the administrative requirements of the Organization, the rate of which will be agreed upon by the IOM Council and the Government of the Republic of Azerbaijan.

I am confident that your Government's action will be received with satisfaction by the Member States of IOM. At the same time, I should like to express our deep gratification at this further strengthening of the already close and cordial relationship between the Republic of Azerbaijan and IOM.

I am pleased to confirm that the necessary steps will be taken to place your Government's application for membership on the agenda of the next session of the IOM Council, to be held in Geneva at a date which will be communicated shortly.

A document formally presenting your Government's application for membership will be distributed to all Member States and observers. You will receive a copy of it, together with further details concerning the Council session and the procedure for consideration of your country's application.
