### APPLICATION BY THE <u>UNION DU MAGHREB ARABE (UMA)</u> FOR REPRESENTATION BY AN OBSERVER

- 1. In a letter dated 17 July 2001, a copy of which is appended as Annex I, the Secretary General of the *Union du Maghreb Arabe (UMA)* made a formal application for his organization to be accorded observer status at meetings of the IOM Council. The Director General's reply thereto, dated 24 July 2001, is appended as Annex II. An appropriate item will be included on the provisional agenda of the Eighty-second Session of the Council.
- 2. This matter falls under rule 10 of the Rules of Procedure for the Council which provides that the Council may admit, upon their application, international organizations, governmental or non-governmental, concerned with migration, refugees or human resources as observers at its meetings.
- 3. If the Council so decides, the *Union du Maghreb Arabe* will be included among the governmental organizations listed in paragraph 2 (a) of Resolution No. 753 (LVIII).
- 4. An appropriate draft resolution will be submitted to the Council when this matter comes up for decision.
