APPLICATION BY THE REPUBLIC OF MOLDOVA
FOR MEMBERSHIP IN THE ORGANIZATION

1. In a letter dated 29 May 2003, the Republic of Moldova applied for membership in the International Organization for Migration. A copy of the foregoing letter and of the Director General's reply, dated 3 June 2003, are annexed.
2. In accordance with Article 2 (b) of the Constitution, the Council is required to make a decision regarding the application of the Republic of Moldova for membership and the rate of its contribution to the administrative requirements of the Organization, which the Director General recommends should be assessed at 0.040 per cent of the total contributions required from Member States to the Administrative Part of the Budget.
3. An appropriate draft resolution will be submitted for consideration by the Council.

LETTER DATED 29 MAY 2003 FROM THE MINISTER FOR FOREIGN AFFAIRS,
MINISTRY OF FOREIGN AFFAIRS OF THE REPUBLIC OF MOLDOVA,
ADDRESSED TO THE DIRECTOR GENERAL OF THE
INTERNATIONAL ORGANIZATION FOR MIGRATION

Sir,

I have the honour to refer to the relationship existing between the Republic of Moldova and the International Organization for Migration (IOM).

The Republic of Moldova wishes to establish a closer relationship with IOM and hereby applies for membership in the International Organization for Migration in accordance with Article 2, paragraph (b) of the IOM Constitution.

The Republic of Moldova accepts the Constitution in accordance with its constitutional procedures and the obligations resulting from membership. It also undertakes to make a financial contribution to the administrative requirements of the Organization, the rate of which will be agreed upon by the IOM Council and the Government of the Republic of Moldova.

LETTER DATED 3 JUNE 2003 FROM THE DIRECTOR GENERAL
OF THE INTERNATIONAL ORGANIZATION FOR MIGRATION
TO THE MINISTER FOR FOREIGN AFFAIRS,
MINISTRY OF FOREIGN AFFAIRS OF THE REPUBLIC OF MOLDOVA

Sir,

I have the honour to acknowledge receipt of your letter of 29 May 2003, No 03/2-4079, in which you inform us that the Republic of Moldova wishes to become a Member of the International Organization for Migration (IOM), in accordance with Article 2, paragraph (b), of the Constitution.

I note that your Government accepts the Constitution of IOM in accordance with its constitutional processes, as well as the obligations resulting from membership, and that it undertakes to make a financial contribution to the administrative requirements of the Organization, the rate of which will be agreed upon by the IOM Council and your Government.

I am confident that your Government's action will be received with satisfaction by the Member States of IOM and would like to express my deep gratification at this further strengthening of the already close and cordial relationship between the Republic of Moldova and IOM.

I am pleased to confirm that the necessary steps will be taken to place your Government's application for membership on the agenda of the next session of the IOM Council, to be held in Geneva on 13 June 2003.

A document formally presenting your Government's application for membership will be distributed to all Member States and observers. You will receive a copy of it, together with further details concerning the Council session and the procedure for consideration of your country's application.
