We expect the materials to be accessible to different stakeholders, including persons with disabilities, minority groups, and persons of different genders and ages. IOM, WFP, and the service provider will be responsible for ensuring the necessary safeguarding measures are in place.
3. Does output 5 require service providers to create the new products or just to advise on the use and adaptation of the final package?	To advise, adapt, and create new products.
