I. Technical Inquiries

Question	Answer
1. How will the NFI kits be packed/kitted?	You may utilize the 40L bucket to contain the small items under the kit. If not possible, vendor may pack in robust boxes per kit.
2. How will the emergency shelter kits be packed/kitted?	Please use a woven sack, of synthetic material containing above items as kit, colour: white or gray, closed with string or wire.
3. How will the winterization kits be packed/kitted?	The goods can be put in a PE bag with strong handles, vacuum sealed.
4. How will the hygiene kits (1 month IDP) be packed/kitted?	Vendor may pack in robust boxes.
5. How will the hygiene kits (3 month IDP) be packed/kitted?	Vendor may pack in robust boxes.
6. How will the collective institutional hygiene kits be packed/kitted?	Vendor may pack in robust boxes.
7. For lot 2, item 2.6 – Is this wooden batten? If yes, do you need fumigation or heat treatment, or both?	No specific need on our end. Please ensure that the offered goods meet exporting regulations on the country of origin.
8. For lot 2, item 2.10 – we don't have OSB, we can supply plywood	This is acceptable.
