

## Potential formats of engagement by interested inter-State consultation mechanisms on migration (ISCM) in the regional reviews of the Global compact for safe, orderly and regular migration<sup>1</sup>

The below chart seeks to provide IOM colleagues with a non-exhaustive overview of how [inter-State consultation mechanisms on migration](#) (ISCM) could contribute to the regional reviews of the [Global compact for safe, orderly and regular migration](#) (GCM). The [UN Network on Migration](#) seeks to weave together a process – or series – of discussions, across a range of venues and throughout the year, contributing to a greater understanding of regional and sub-regional migration issues. There is no one forum, no one event, no one outcome, which can be considered to be a ‘regional review’. Therefore the ISCMs can choose from a variety of below types of inputs that can be submitted directly or indirectly or a combination of such inputs. These inputs should be possible to be compiled with minimum resources and time, but will constitute a big relevance for the GCM review process and for reconfirming the ISCMs’ central role in regional governance of migration.

<b>Oral statement</b> on behalf of the ISCM at the GCM regional review event hosted by the respective UN Regional Economic Commission (UN ReC)	Directly by the ISCM (e.g. the ISCM (Co-)Chair, or the (Co-)Head of the ISCM Secretariat, or the Chair of the ISCM’s Working Group on the GCM, or another member of the given ISCM as delegated by the ISCM Chair)  Indirectly by a Member State or a group of Member States of the given ISCM  Indirectly by an intergovernmental organization with which the given ISCM has a formal association	UN ReC-hosted GCM regional review event
Submission of a <b>written input</b> by the ISCM in accordance to the format suggested in the UN Network on Migration’s <a href="#">proposed framework for GCM regional reviews</a>	Directly by the ISCM (e.g. the ISCM Chair or the Head of the ISCM Secretariat)	Directly to the UN NoM Secretariat  To the UN ReC-hosted GCM regional review event
<b>Own ISCM event to review</b> the progress of the GCM implementation within its ISCM region	Directly by the ISCM	ISCM event

<b>Joint submission</b> of a written input by a group of ISCMs covering the same or similar regions (following the format suggested in the UN Network on Migration's proposed framework for GCM regional reviews)	Directly by the group of partnering ISCMs and IGOs (e.g. by a jointly designated member representing all the ISCMs and IGOs involved and acting on their behalf)	Directly to the UN NoM Secretariat UN ReC-hosted GCM regional review event
<b>Joint statement</b> at the GCM regional review event hosted by the respective UN ReC by two or more ISCMs covering the same or similar regions	Directly by the given ISCMs (e.g. by a jointly designated member representing all the ISCMs involved and acting on their behalf)	Directly to the UN NoM Secretariat UN ReC-hosted GCM regional review event
