



## RETURN OF UNDOCUMENTED AFGHANS

WEEKLY SITUATION REPORT

12-18 February 2021

### HIGHLIGHTS

**110,254** total returns from **Iran & Pakistan** since 01 January 2021

**109,064** total returns from Iran in 2021

**1,190** total returns from Pakistan in 2021

Over the past week, **22,034** undocumented Afghans returned from Iran with 6% of returnees from Iran (1,331 individuals) assisted

Over the past week, **314** undocumented Afghans returned from Pakistan with 91% of returnees from Pakistan (287 individuals) assisted

### Migration Health

*\*\*As of February 2021, funding availability in Afghanistan for all major health stakeholders and COVID-19 response agencies is ending. It is critical that additional funding resources are made available to ensure that essential response functions inclusive of Rapid Response Teams, surveillance, support to laboratory testing, PPE provision and health education/community engagement can continue without a gap and vaccination preparedness towards eventual delivery and roll out can proceed.\*\**

In 2021, 91,429 patients have been served by IOM's Migration Health Unit in Nimroz, Herat, Kandahar and Nangarhar provinces with basic health care- outpatient consultations, maternal, child and neo-natal health care, reproductive health, family planning and COVID-19 response. Programming is supported by the UK's FCDO, DG ECHO, CERF, and the United

States' Bureau for Population, Refugees and Migration (BPRM). During the past week a total of 11,282 patients were served by IOM's 7 mobile health teams, inclusive of 3,731 outpatient consultations, health education sessions for 11,282 persons and psychosocial counselling sessions for 2,238 patients. Under the Global Fund multi-country TB grant in partnership with UNDP, a total of 7,297 undocumented Afghans were screened for tuberculosis at the Zero Point Reception Centres in Herat, Nimroz, Kandahar and Nangarhar. Of the total screened, 251 presumptive TB cases were identified and samples lab tested and 7 persons were confirmed positive for TB.

#### **Protection**

IOM's Protection programme has supported 431 undocumented returnee households comprising at least one person with specific needs (PSN) in 2021 through provision of timely information, facilitating safe and dignified access to services, and provision of assistance including cash to mitigate identified protection risks and avoid resorting to negative coping mechanisms when referral pathways are exhausted. With screening staff at the Herat and Nimroz border points as well as case workers in 12 provinces of return, the Protection team caseload this week included case management assessments for 106 new PSN households in Kunduz, Badakhshan, Nimroz, Sar-e-Pul, Balkh, Nangarhar, Ghor, Herat, Takhar, and Faryab . These cases included 18 children at risk, 13 persons with serious medical conditions, 6 single parents, 6 women at risk and 1 older

person at risk . Across all provinces, 2,271 cases are ongoing. 984 PSN individuals (and their households) were identified at the Milak and Islam Qala border points by Protection screeners in coordination with DoRR.

In addition, the Protection team conducted regular COVID-19 protection monitoring surveys in collaboration with the Afghanistan Protection Cluster. This week, 65 households were surveyed, all of whom received specific WHO information and RCCE messaging on COVID-19 awareness and prevention relevant to their location.

### **Return from Iran**

**\*\*On 13-14 February, a devastating fire led to the explosion of hundreds of fuel tankers at the Islam Qala customs depot in Herat resulting in 17 injuries according to the Government of Afghanistan. Fortunately, all humanitarian workers including IOM's field team were unharmed in the incident. However, the nearby reception center facility was partially damaged and assessments are ongoing.**

According to the Border Monitoring Team of the Directorate of Refugees and Repatriation (DoRR), a total of 22,034 Afghans returned from Iran through the Nimroz (Milak) and Herat (Islam Qala) borders

between 12-18 Feb 2021. 5,650 persons returned voluntarily and 16,384 were deported. This represents a 27% increase in the total number of returns from the previous week. Since 01 January 2021, the total number of undocumented returnees from Iran is **109,064 individuals- more than double the 2019 and 2020 rates of return through the months of January and February.** In 2021 under the revised Afghanistan Humanitarian Response Plan, IOM is projecting a return of 654,000 undocumented Afghans, 100% of whom will be in need of humanitarian assistance. IOM is seeking 29.7m USD to provide post arrival humanitarian support to this caseload.

### Return from Pakistan

According to the Directorate of Refugees and Repatriation (DoRR), 1,190 undocumented Afghans have returned from Pakistan since 01 January 2021. Over the past week 314 undocumented Afghans returned from Pakistan through the Torkham (21 returnees and 17 deportee) and Spin Boldak (276 returnees) borders. Returns are lower in the colder winter months.



IOM has been actively supporting the Ministry of Public Health (MoPH) and WHO in addressing emergency response actions through its Cross Border Return, Migration Health and Displacement Tracking Matrix (DTM) Units however **funding will end for COVID-19 interventions on 28 February 2021.**

IOM support is focused across 4 of WHO's Response Pillars including 1. Coordination; 2. Risk Communication-Community Engagement; 3. Surveillance/DTM; 4. Points of Entry. Activities include training for frontline health workers, deployment of staff to areas of need including health facilities, secondment of staff to cross border surveillance, material support of PPE and other equipment, ambulance based referral services, distribution of MOPH-WHO IEC materials and community level awareness raising and sensitization efforts through health education sessions including within Displacement Tracking Matrix focus group discussions in over 12,600 settlements across 34 provinces.
